SLU: What can recourses can nationals hosts get if institutions don't pay? UPD: Nationals hosts have the prerogative to set deadlines to be met. Mikee: Institutions that pull out lastminute without paying are not eligible to participate in the next nationals until they pay. Policy on Pull-Ups Miko: We should discuss if we want to implement a rule banning more than one pull-up. UPD: There are logistical issues involved. Tab Team: The tab used this year does not allow manual changes. Mikee: Any decision on the pull-out rule will not affect this year's PIDC, only next year. We need alternative programs proposed.
